CONTRACT RULES:

Set up is Sunday, September 20th from 7:00 to 9:00 AM. Dealers must be set up by 9:00 AM. Only those identified by name on the dealer contract will be allowed admission during setup hours. A maximum of two persons will be allowed per dealer contract. Sub-leasing of tables is prohibited.

Dealers will not pack or leave prior to 2:00 PM. Strict adherence to this rule is expected.

GBBCA will guarantee no refund of acknowledged reservations. We will make every effort to fill a canceled reservation and if successful, a refund will be made less any expense incurred.

GBBCA reserves the right to determine eligibility of any dealer or items offered for sale, including collectibles. Acceptable items include antique bottles, milks, fruit jars, insulators, stoneware, advertising, breweriana, collectibles, postcards, books and antiques. All items must be visibly priced by the opening of the show. Any defective, repaired or reproduction items must be so marked.

Tabletop racks will be allowed, but within the confines of the rented table, either above or directly below the table. Audio and/or visual effects, furniture or extra tables will not be permitted. Dealers must supply their own table covers.

Dealers agree to hold harmless the GBBCA, its members and the Polish Falcons from loss of or damage to dealers' property by theft and/or accidental causes. Dealers understand that they will be fully responsible for the protection of their property while at the show location and that the GBBCA, its members and the Polish Falcons will not be responsible for loss or damage to dealers' property.

Only those wearing name badges will be given access to the building during setup.

SHOW POLICY

Please read: All past dealers have until July 1st to mail in their contract and check. After July 1st any unsold tables will be available to anyone. New Dealers: Sometimes new dealers are anxious to secure a table and send in check early. If your payment and contract are received before July 1, your name will go on a preferred waiting list. On or about July 1, you'll be contacted to confirm if table (s) is available. If no table (s) are available, your payment will be refunded. You can also phone to be added to the waiting list, without sending in check and contract beforehand. Around July 1, the chairman will contact you, confirm that tables are available, and to request that you mail a contract and check. It's a good idea to speak with chairman around that time for clarification, updates or questions. The idea behind the holding of table(s) until July 1st, is that we have had dealers support our show for 25 years and because contracts go out so early, we don't want a new person to take the tables by sending in contract before a veteran dealer is able to do so. All past dealers, I recommend sending in contract when you receive it and have checked your calendar.

Request for 2nd table is only available for dealers who have always had 2 tables. Requests by new dealers for a 2nd table are only available if there are workable cancellations.

Phone or email contact with show chairman-Tom Karapantso-is the best way to check on table availability, but the contract and payment in his possession is the ONLY way to guarantee a reservation.
